LIMITED POWER OF ATTORNEY FOR SECTION 16 REPORTING PURPOSES

Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of Richard N. Phegley, Leland P. Smith, Philippa M. Bond and Christopher D. Ahn, acting individually, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

- execute for, and on behalf of, the undersigned, in the undersigned's capacity as an officer and/or director of Smart & Final Stores, Inc. (the "Company"), Forms 3, 4, and 5 relating to the Company in accordance with Section 16(a) of the Securities Exchange Act of 1934 and the rules and regulations promulgated thereunder (the "Exchange Act");
